PRODUCT DESCRIPTION

SpectralInfill is produced from granulating recycled SBR rubber which is processed, classified and graded to meet internationally required infill standards. Using a licenced and patented colouring technique, each granule is fully encapsulated in a UV stable and colour-fast pigmented polyurethane.

APPLICATION

SpectralInfill is pre-coloured SBR rubber granules used as infill for artificial turf sport pitches.
